



## INDEMNITY FORM

### Access:

- The right of access to the premises of Babilu is reserved at all times.
- All persons that enter the premises of Babilu do so completely at their own risk.
- All persons, parents and parties to the agreement that enter the premises of Babilu, agree to observe and obey the rules of Babilu and confirm that all rules are incorporated in this agreement.
- No child will be accepted at Babilu before the Indemnity form is completed and signed.

- I/we am/are aware that Babilu may arrange activities like educational visits and other activities as necessary to add to the educational curriculum of the centre.
- I/we understand that although Babilu undertakes to take all necessary steps to ensure the safety of your child when in our care that it does not constitute a guarantee of the safety and welfare of the child at all times.
- I/we hereby grant permission that my/our child may take part in any official organized activity of the centre. In case that I/we wish to cancel this permission or in case of any specific instruction regarding participation I/we undertake to inform Mrs Bezuidenhout in writing.

I/we further grant permission that:

- In case of transport being needed in any case, like for example in case of emergency, I/we grant permission for my/our child to be transported by a mandated and specified person.
- In the case that medical treatment/surgical procedure is needed during emergency and Babilu have exhausted all reasonable methods of contact with me/us, I/we grant the centre manager (Mrs Bezuidenhout) the right to authorize any necessary treatment.
- I/we declare that according to my/our knowledge that my/our child is physically fit to participate in all activities offered by the centre and that he/she is in good health. I/we declare further that we have informed the centre of any physical disabilities that may affect my/our child's daily interaction.
- I/we indemnify all members of Babilu against claims or responsibility that may occur after the loss or damage to property, physical injury, illness or death that may affect me/us or my/our child that pertains to my/our child's participation in the activities of the centre.
- I/We agree that I/we will be held liable for the payment of any expenses or medical costs in the case of injury to my/our child.
- I/we take note that in the case of my/our child's participation in extramural activities that the centre cannot be held liable for my/our child's health and safety.
